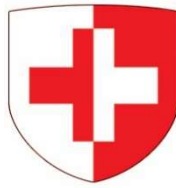

The Income and Expenditure for Quarter 3 is registering a surplus of €186,533. The annual budget for the year 2023, envisaged a deficit of €129,158 for the year. A virement re Refuse Collection and Street Lighting has been made, and the revised budget 2023 envisages a surplus of €842 for 2023.

The net current asset for the period is positive as the net current asset position is €227,835. This positive situation is due to the fact that the cash and cash equivalents were very high and in fact the balance as at end of September 2023 amounted to €420,427.

The results above confirmed that the financial situation is positive as the net position (i.e current assets, current liabilities and total long term liabilities) was positive and it amounted to 20% of the Annual Government Allocation.
