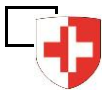

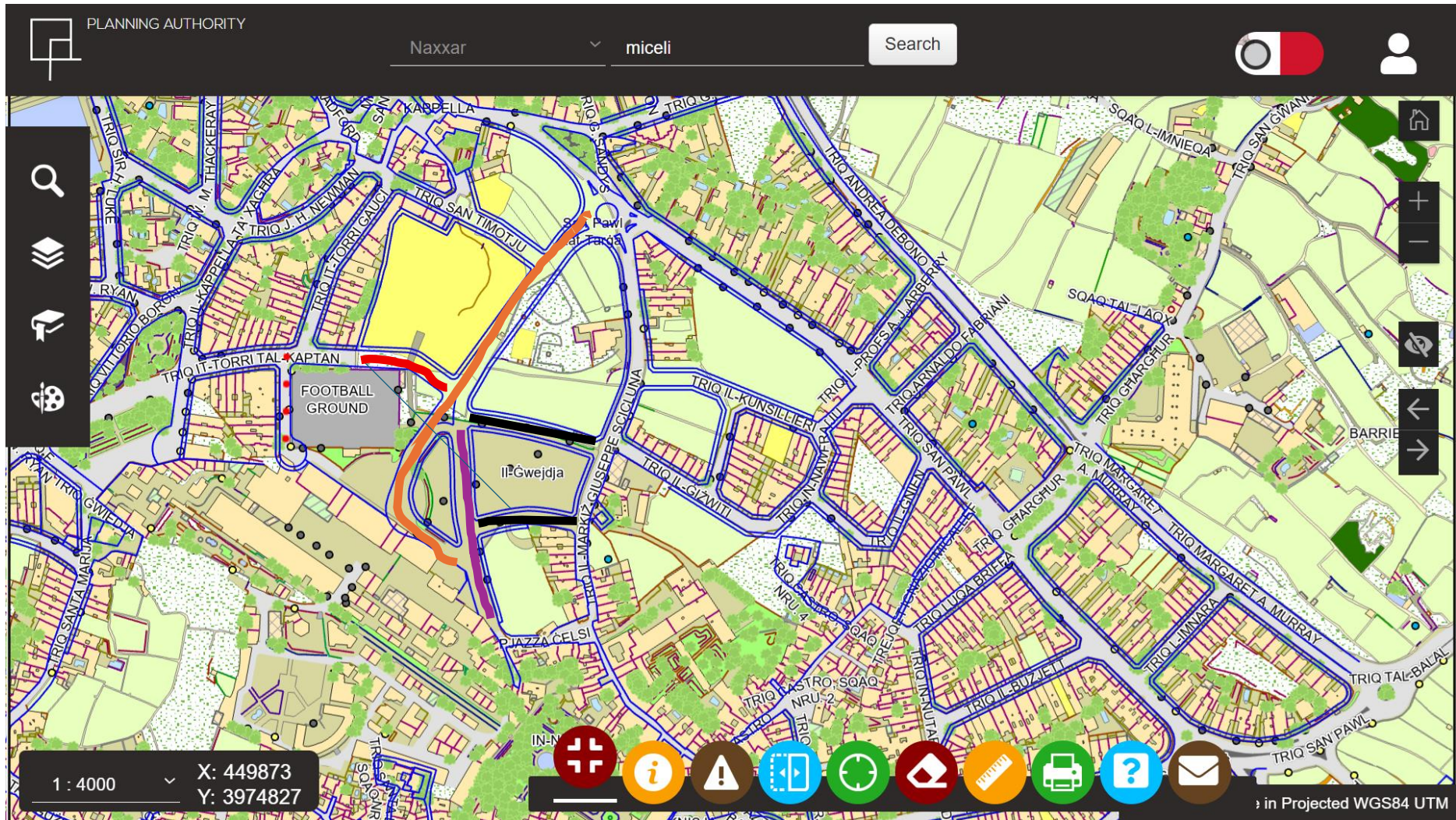
Appeal Period





In accordance with public procurement regulations, there is an appeal period during which an appeal may be filed. This appeal period is open until **26th September 2025 at 2:00 p.m.**

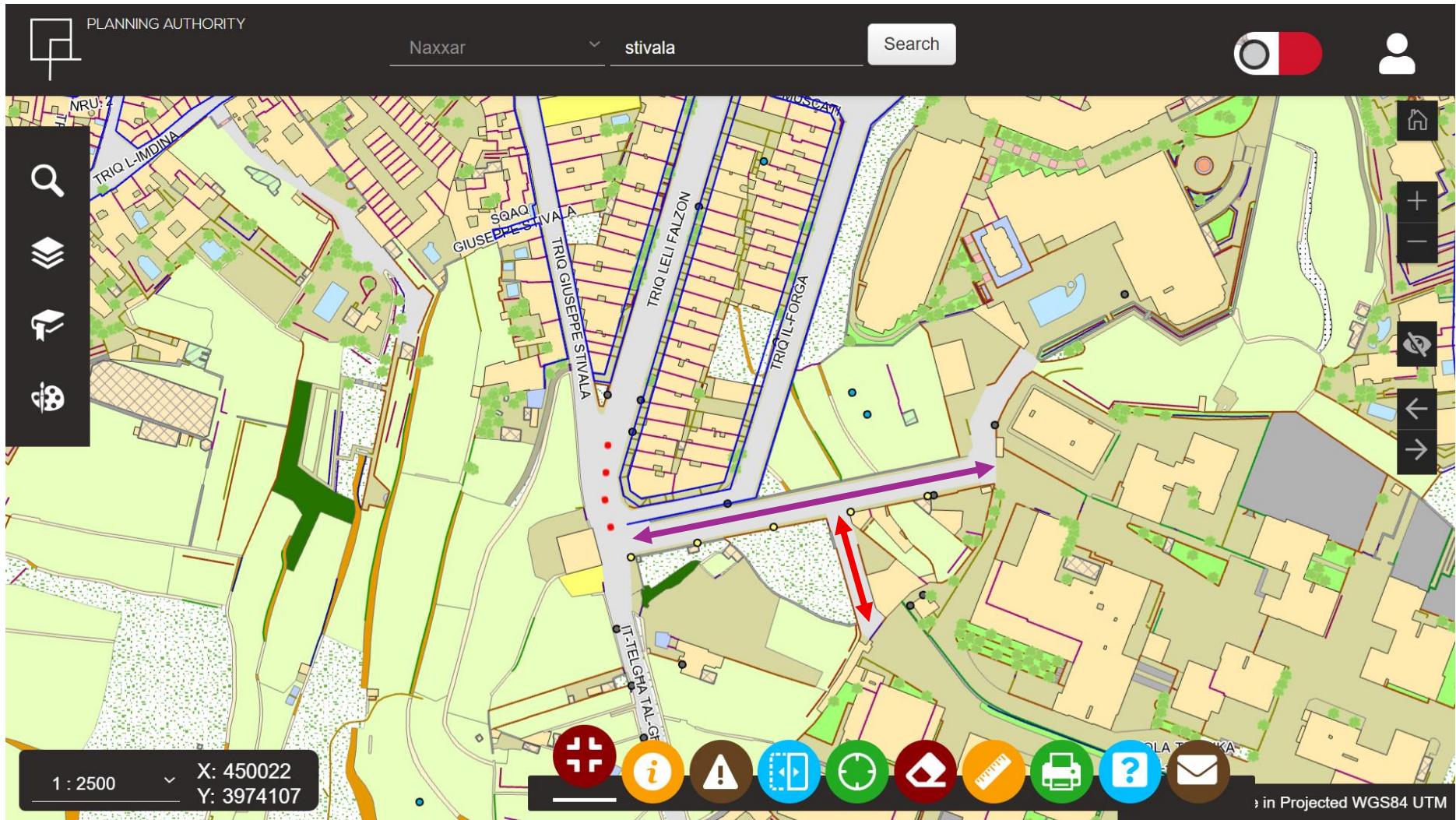
Conclusion
